# 1 Document Introduction

This document is to be used as a technical guide and serves as a supplemental reference to the formalized training conducted by CASI (Cornerstone Automation Systems, LLC), or one of its designees. It is intended as a reference for system operations and basic troubleshooting.

#### 1.1 PROPRIETARY INFORMATION

This document and the information contained herein, including attachments, are proprietary to CASI (Cornerstone Automation Systems, LLC). It is not to be disclosed to competitors, third parties, vendors, or others without the prior written consent of an officer of CASI. All intellectual properties, concepts, trademarks and designs relating to this project and provided by CASI (Cornerstone Automation Systems, LLC) remain the property of CASI.

# 2 Safety

The system is equipped with a safety circuit provided by CASI. The safety circuit is separate from the controls circuit. The safety circuit is intended to remove air and power from all equipment regardless of the status of the Control System.

A series of pull cords, mushroom pushbuttons and/or interlocks are used to control the safety circuit. When the E-Stop is activated, the CASI CORE Controller will display and sound an E-Stop notification.



**WARNING:** Please review this document as well as all **Original Equipment Manufacturer's** or (*OEM*) manuals supplied with this system and any other relevant manuals carefully to understand safe operating, troubleshooting and servicing procedures.

### 2.1 GENERAL SYSTEM SAFETY

- First and foremost, *NO* maintenance should ever be performed until the system has been properly powered down and **Lock-Out Tag-Out** (*LOTO*) procedures implemented. It is the end user's responsibility to establish LOTO procedures that meet their facility's safety requirements.
- Risk of electric shock, pinch point injury, system devices and components energizing and contacting personnel among other injuries could occur if the system is operated or maintenance work is performed in an unsafe manner. Care should be taken at all times when working with moving, rotating, and electrically energized machinery.
- All operation and maintenance should be performed by trained and competent individuals.

### 2.2 CONVEYANCE SAFETY

 After completion of conveyor installation and BEFORE operation, personnel operating the conveyor must be properly trained in its use. It is recommended these employees be walked through the proper sequence of starting and stopping the motor drive, shown where hazardous areas exist along the length of the conveyor (identified by safety labels attached to the conveyor frame and drive guards) and correct loading and unloading methods. Make sure that safety labels are legible and that personnel understand their meaning.

- Conveyor should **NEVER** be operated with any of the safety guards removed as physical harm could come to the user. All pinch points of the conveyor are guarded and also identified by safety labels attached in the guarded pinch point area. Instruct users to turn the conveyor off and notify the proper personnel should a guard be missing and the conveyor is running. Safety characteristics of the conveyor should **NEVER** be altered if such alterations would endanger personnel.
- Only qualified maintenance personnel should perform work on the conveyor. Should the unit require maintenance, disconnect conveyor motor drive from power source before attempting to adjust or repair conveyor. If guards were removed to perform the maintenance task, they must be replaced before attempting to operate conveyor. If guards are damaged and become unusable they must be replaced.
- Personnel should be alerted to the potential hazard of entanglement in conveyors caused by such items as long hair, loose clothing, and jewelry.

#### 2.3 BAR CODE SCANNERS AND PHOTOEYES SAFETY

Lasers are often used in these systems and devices. As a general safety practice, regardless of the laser's strength, avoid staring at the beam as one would with any very strong light source, such as the sun. Do not point laser beams at other people. Avoid any alignment where the laser beam hits the eye of an observer, even thru reflective surfaces such as mirrors, etc.



#### 2.4 SORTERS, PUSHERS AND DIVERTERS SAFETY

- Just as with conveyors, personnel should be made aware of all potential hazards from entanglement, crush and pinch points.
- All power and air should be shut-off or disconnected before performing any maintenance or repairs.
- These systems should **NEVER** be operated with safety guards and devices removed, disabled or by-passed.

# 2.6 EMERGENCY STOP (E-STOP) SYSTEM

The **Emergency Stop (E-Stop) System** uses **Emergency Stop (E-Stop) Buttons** to activate the safety circuit. Pushing an E-Stop button causes system components, including drive rollers, drive cards, photoelectric sensors (photoeyes), and VFDs (Variable Frequency Drives) to halt. The E-Stop buttons also shut down all of the air dump valves and cause all pneumatic air to be exhausted from the system.

In the event an E-stop device is triggered, an announcement is made on the CASI CORE HMI (Human Machine Interface).

For immediate system shut down, push a red E-Stop button to completely turn off the system. **This function should only be used in an actual emergency.** After resolving the issue that triggered the necessity of the E-Stop, follow these steps for mechanical operation to resume.:

- 1. Turn the E-Stop button clockwise.
- 2. Press the Reset button on the CORE HMI.
- 3. Press the Start button on the CORE HMI.

A **Designated Person** should check the emergency stop (E-stop) buttons for proper operation, physical damage, button looseness, and excessive environmental contamination. This should take place on a periodic schedule determined by the user, based on the severity of the operating environment and the frequency of switch actuations. Adjust, repair, or replace components as needed. If inspection reveals

contamination on the switch, thoroughly clean the switch and eliminate the cause of the contamination. Replace the switch and/or appropriate components when any parts or assemblies are damaged, broken, deformed, or badly worn; or if the electrical/mechanical specifications (for the environment and operating conditions) have been exceeded. **Always test the control system for proper functioning** under machine control conditions after performing maintenance, replacing the emergency stop device, or replacing any component of the device.

CASI recommends the end user conduct a risk assessment and risk reduction analysis (see ISO 12100 or ANSI B11.0) to determine the appropriate frequency for E-stop system checks. In lieu of the assessment and analysis, test each component before start of each production day. Refer to the <u>E-Stop System Check</u> <u>Procedure</u> for the process to check the E-stop system.

### 2.6.1 EMERGENCY STOP RESET PROCEDURE

#### 2.6.1.1 General

When an emergency stop is pressed all power is removed from the system IO. This is accomplished by de-energizing the safety relay. The safety relay in turn opens its contacts. The opening of these contacts removes power from the PS100 boxes in the field. The PLC places the system into E-Stop Recovery mode. E-Stop recovery mode forces all sorters to an occupied state and controls the startup of the Manifest line in a way that allows it to empty out from head end to tail end.

The operator returns the system to normal operation by first resetting the pushbutton that was activated. The second step is to click on the "Emergency E-Stop Reset" icon on the CASI CORE HMI (Human Machine Interface). Activating this icon energizes the safety relay and begins the recovery process.

#### 2.6.2 E-STOP SYSTEM CHECK PROCEDURE

Follow these steps to check the Emergency Stop (E-Stop) system:

- 1. Press an E-Stop Button
- 2. Verify that **all** mechanical functionality stops through the entire system.

- 3. Reset the E-Stop by turning the red mushroom pushbutton clockwise.
- 4. Press the Reset the E-Stop button on the CORE HMI (Human Machine Interface)
- 5. Press the green **Start** button on the CORE HMI to restart the system.

#### 2.6.3 RESTART ROUTINE AFTER AN E-STOP

- 1. Resolve the issue that triggered the necessity of the E-Stop.
- 2. Reset the E-Stop device that was triggered.
- 3. Press the Emergency E-Stop Reset button on the CORE HMI.
- 4. Press the green **Start** Button on the CASI CORE HM.

#### 2.6.4 DAILY SYSTEM SHUTDOWN

- 1. Click the system's **STOP** button (preferred) on CASI CORE Main screen to stop all pieces of equipment on the system.
- 2. Click the **EXIT** icon on the SolidSuite<sup>™</sup> interface.
- 3. Shut down CASI CORE HMI.
- 4. Power down (turn **OFF**) all associated equipment and/or turn **OFF** disconnects according to current plant procedures and practices.

# **3** Operational Requirements

The following requirements **must be implemented** before and during equipment operations:

- Ensure all units are within specification.
- Ensure all inbound units are in the proper orientation for processing.
- Only use Emergency Stop (E-Stop) devices in cases of emergency.
- Use a soft stop to STOP/HALT the system in non-emergency scenarios.
- Always attend to operator alerts and system errors on all equipment and sub-systems.
- Ensure there are no jams or product on the CASI line at system start up.
- Perform all preventive maintenance as required and specified by CASI.
- Purchase spare parts before the delivery of the system to the site to allow for spares availability during installation and start up.

# 4 System Overview

This CASI system provides Walmart with a receiving dock scan and sort system to unload boxes from trucks (trailers), and sort them onto carts. This results in more accurate sorting, prioritizing out of stock items and quicker stocking of shelves. Cartons are sorted by department, category, or store aisle.

# 5 System Mechanical Functionality

This section explains the mechanical functionality of the components of this system.

### 5.1 CASI CORE HMI (HUMAN MACHINE INTERFACE)

The CASI CORE HMI (Human Machine Interface) consists of an all-in-one computer and touch-screen monitor. It is mounted on the side of the Scanning Module, as shown in the following figure. The barcode scanner with communication box and CASI SM-101E SortMaster<sup>™</sup> Bi-Directional Sorters communicate with the CASI Core HMI.

# 5.2 AFLEX - AGILITY FLEXIBLE CONVEYORS

The AFLEX conveyors stretch from inside a truck to the front of the CASI system. The initial setup of the system includes one (1) flexible conveyor. Additional flexible conveyors are added to the system as the truck gets emptied.

#### 5.2.1 CARTON PLACEMENT ON AFLEX CONVEYOR

The Thrower places each item on the flex conveyor with the RDC label facing up. It is important to keep a consistent speed and quality of placement in order to have a successful unload. Going too fast will jam the machine and cause slowdowns. Going too slow will cause the unload to be ineffective. Note: Items should have a flat bottom.

**Note:** Oversized items **must no**t be placed on the conveyor. Examples are swimming pools, grills, lawn mowers, furniture, etc.

**Note:** Items that are odd shaped or do not travel down the conveyor safely must not be placed on the conveyor. Examples are fishing poles, 5-gallon paint buckets, bagged dog food, bagged rice, weights, etc.

# 5.3 GAPPING CONVEYOR (OPTIONAL ON SOME SYSTEMS)

The flexible conveyor attaches to the CASI Gapping Conveyor, which puts space between boxes before they enter the CASI Halo Scanning Module.

**NOTE:** Not all systems have a Gapping Conveyor. On some systems, the flexible conveyor hooks directly to the truck side of the Halo Scanning Module.

# 5.4 HALO SCANNING MODULE

A barcode scanner reads the RDC shipping label on the item to determine which lane to sort the item to.

# 5.4.1 DATALOGIC BARCODE SCANNER

The DataLogic DX8210 Barcode Scanner scans the barcode label on the top of the item and the CBX510 Communication Box relays the information to the CASI PLC.

#### 5.4.3 SYSTEM INDICATOR LIGHTS

There are a set of indicator lights on both the front and back of the Scanning Module. These red, yellow and green lights indicate the status of the system.

The colors have the following meanings:

1. Red – System has been-stopped by an E-stop (Emergency Stop) button

2. Yellow

- a. Flashing Lane full or system starting
- b. Steady Sorter or ZPA jam
- 3. Green System is running without error

CASI SM-101E SortMaster<sup>™</sup> Bi-Directional Sorters are used in this system. These sorters route boxes from the main conveyor line onto the sorter conveyors.

# 5.7 REJECT LANE / MANUAL CONVEYOR

The Reject Lane / Manual Conveyor is provided by Walmart and placed at the end of the system, behind the last Sorter Module.

# 5.8 PRODUCT RECOGNITION PHOTOELECTRIC SENSORS

Throughout the system, conveyors have product recognition photoeyes mounted beneath the conveyor rollers, as shown in the following figure. As a box passes over of them, the photoeyes trigger the drive rollers to start or stop that section of the conveyor.

Other product recognition photoeyes indicate when a sorter lane is full, which stops the system until boxes are removed from that lane. Once the photoeye is clear, normal system operation resumes.

# 5.9 DRIVE ROLLERS AND DRIVE CARDS

The conveyors consist of idler rollers, drive rollers, and drive cards. There is one drive roller and drive card per section of conveyor. The drive roller is the first roller of each conveyor section. This drive roller pulls the idler rollers in that section of the conveyor.

# 6 Assembling the System

The following directions are used to assemble the system.



5. Connect cables between all modules and flex conveyors.





6. Plug overhead power cord (dropped from ceiling) into Scanning Module.
 Important Note: Do NOT plug into the power cord until all cables have been hooked together!

7. Press all **Start** buttons on the flex conveyors (there is one on both sides of each flex conveyor). The flex conveyors will not start until all Start buttons are pressed.

Note: Pressing a **Stop** button on a flex conveyor will only stop all 3 flex conveyors – it will **not** stop the system.



- 8. Unfold wings from sorter modules.
  - a. Lift the wing from side of sorter module.
  - b. Unhook black easy-disconnect hook strap.
  - c. Rotate wing around pivot pin until fully opened.



 Position Topstock Carts (provided by Walmart) between the Sorter Modules. Position extra Topstock Carts as directed by your supervisor.



10. Proceed to the System Operation for Operators procedures.

3. Click the <b>Start</b> button. Dome light blinks blue several times then turns green – system is ready and sorter modules are initialized.	
Note: The Start button toggles to a Stop button that	_

a. Place boxes on flex conveyor, narrow edge leading.	
b. Boxes must have a hard, flat bottom.	
c. Barcode label must be on the top of the box.	
d. Minimum box size is length 6" x width 6" x height 1".	
e. Maximum box size is length 48" x width 25" by height 30".	
f. Maximum box weight is 55 lbs.

a. Do not allow more than a total of 150 lbs to accumulate on a sort conveyor.	
b. If a sort lane (gravity conveyor) is full and a box needs to go there, the box will stop on main co	nveyor.

a. If problems are encountered, go to the System Troubleshooting procedures	
b. If another trailer is to be unloaded, go to Unloading a Trailer, above in this procedure.	
c. If no other trailers are to be unloaded, go to the System Tear Down & Put Away procedures

#### Table 5 – System Troubleshooting

- 1. If a box has stopped on a sorter module or sorter infeed (rollers) and the dome light is **yellow**:
  - a. Look on the screen and identify the location of the stopped box.
  - b. Remove the box and place in the appropriate location.
  - c. The system will start automatically. (You don't have to push start).
- 2. If a box has stopped on a sorter module and the dome light is <u>red</u>:
  - a. Check to see if E-stop button(s) are pressed.
  - b. If so, reset E-stop button.
  - c. Press Start.
- 3. If a box has stopped on a sorter module and the dome light is green:
  - a. Wait and observe, a lane is most likely full and the boxes will move once a lane is cleared.

#### Resetting the Software

- 1. Select the **Reset** tab.
- 2. Click the **Reset the System** button. On the popup message, **Are you sure?**, click **Yes**.
  - Pushing the Reset button will close and restart the system and should only be done after all other troubleshooting efforts have failed to solve the problem.
  - b. Remove all boxes before restarting system and wait several minutes for restart procedure to complete.



#### Removing a Non-Functioning Sorter Module

If a sorter module does not return to operation, follow these steps to remove it from the configuration:

- 1. Press the E-Stop button.
- 2. Remove the Sorter Module (Refer to System Tear Down & Put Away procedures).
- 3. Reset the E-Stop button. This triggers the system to rescan and may take 60 seconds or more.
- 4. The system is ready to resume operation. Press **Start** button.
- 5. Go back through the Daily E-Stop Verification System:
  - A. Press an E-Stop button. It will light up and stay lit until reset.
  - B. Verify that all mechanical functionality stops through the entire system.
  - C. Reset the E-Stop by turning the red pushbutton clockwise and pulling it out.
  - D. Restart the system by clicking the **Start** button.
  - E. Wait for system to check and initialize the sorters.
  - F. Do this for all **E-Stop** buttons before beginning normal operation.

**Note:** If the non-functioning sorter module is the one closest to the reject lane, the E-Stop Terminator cable must be removed from that sorter module and then placed on the sorter module that will then be closest to the reject lane.

#### Table 6 – Monthly Cleaning Guide

Wipe down modules, including photoelectric sensor bars (photoeyes), rollers and all metal surfaces using approved cleaning cloth and cleaning solution, such as window cleaner. **Do not hose down modules!** 

# 7 CASI FAST with AFLEX Conveyors System Startup Procedure

### 7.1 STARTING THE SYSTEM

 After the system is set up and ready, press the START button on the HALO HMI screen.

The FAST (Flexible Automated Sorting Technology) software user interface is part of this proprietary SolidSuite<sup>™</sup> software.

The CASI-SolidControl<sup>™</sup> Management Software interfaces with a SQL database stored locally on the CASI Core Controller. The SQL database stores critical information gathered from each of the peripheral devices on the CASI system.

The SolidSuite<sup>™</sup> Management Software for this system is run on the CASI CORE by SolidControl<sup>™</sup>. The module functions used within this system are listed in the following table.

### 10.9.1 TEST TRAILER MODE

When a system is first commissioned, the first step is to use a test trailer and run test boxes that have matching barcodes, so that the system can be tested before production use.

This button may also be used during maintenance of the system.



During the testing of a new system, the **Test trailer in use** message will show on the screen.

Operate the system as normal in *Test Trailer Mode* to ensure proper set up of the system.

Once the Test Mode is complete a user with the correct permissions level must reset the settings on the *System Tab* for normal operation.

# 10.10 WEBVISUALIZATION (WEBVISU) SOFTWARE

The WebVisualization (WebVisu) software is viewed on the large monitor downstream of the Scanning Module. It allows operators with a means of easily monitoring the system status.

Internet Explorer is used for the WebVisu software. It starts automatically when the CASI CORE HMI is started. The software screen displays on the large TV monitor on the back of the Scanning Module.

## 10.10.5 OUTS WARNING SCREEN

Outs are products that should be taken out to the floor quickly.

The **Outs Warning Screen** displays reminders that are set on a timer.

- When the system is started an "Outs Warning" timer will be started.
- The initial length of the timer will be 20 minutes but will be configurable.
  - The configuration will be controlled by two parameters in the master FAST software.
  - Test Systems These will be configurable via WebVisu as we fine tune the parameters.
- When the timer times out the following will occur.
  - A pop up will appear in the lower right-hand corner of the TV reminding the unloaders to move the outs to the floor.
  - An audible message, "Please move outs to floor" will be played.
  - A "Warning Active" timer will be started.
- The message and popup will be active for 60 seconds. This time will also be configurable as described above. When the timer times out the pop up disappears, and the audible warning is turned off.
- After the Warning Active time has expired the Outs Warning timer will restart.
- During a two-hour unload this will provide 6 reminders.

# 10.14 SHUTTING DOWN THE SYSTEM

# 12.1 DISCLAIMER



**IMPORTANT NOTICE:** Please read this document, all manuals for each individual piece of equipment, and other relevant manuals carefully to understand safe maintenance procedures before performing any routine maintenance on any part of the system.

Care should be taken at all times when working with moving, rotating, and electrically energized machinery.

- The Troubleshooting Guide is intended to provide operators and supervisors assistance in resolving issues while operating the CASI system. Written in an "if-then" style, each problem identified during the installation and start-up of the system is included.

# 12.5 SOFTWARE TROUBLESHOOTING

#### 12.5.1 NOTHING STARTS

- Any estops pushed or broken?
- Check the end estop jumper to make sure it is installed.
- Have you chosen a trailer file?
- Press Start button?
- Have you tried restarting the program?
- Can you press and hold (4 seconds) the PLC reset? Did an error message pop up?
  - If yes reopen the FAST program
  - If No press again till error message pops up.

#### 12.5.2 PROBLEMS WITH A TEE

- Are there any jams showing up on the front monitor?
- Are the sensors clear? If you flag (wave hand over eyes) do you see the orange indicator light illuminate?
  - o If not following cable back to source and make sure still connected
- Can you see anything down inside the sorter that may be jamming the sorter?
- Can you look underneath and see any cables falling out or about to come out
  - Make sure all are seated well and not starting to back out

### 12.5.3 EVERYTHING GOES TO THE END

- Correct trailer file selected?
- Is the scanner on (do you see the laser beam from the scanner)?
- Are the barcodes up?
- Select the Event Log tab and see what the result message is
  - NO READ not scanning barcode or scanner is off
- Make sure loader is loading BARCODE up
  - File Information Missing add on item not included in trailer file Multiple barcodes more than one barcode is being scanned at a time
- Make sure boxes have a least a 2" gap between them
  - Other Barcode Wrong barcode read
- Make sure the barcode from the DC is face up.

## 12.5.4 Boxes Pausing for More Than 3 Seconds

If boxes pause before a sorter for more than 3 seconds, then continues to the reject lane:

- Inspect the sensor leading into the sorter module, chances are there is a bad sensor
   Flag each sensor by hand and look for orange indicator light
- If all sensors check out, inspect the underneath of the sorter for any loose wire connections.

### 12.5.5 MOTOR NOT RUNNING

- Inspect the underneath of the sorter for any loose wire connections.
- Remove the panel under the TEE to inspect the drive cards.
  - Make sure they all have power lights on. If not check the green power plug on the Conveylinx drive cards.

Check that all Sensor/Control/Ethernet Cables/and Motors are firmly seated on the drive card

### 12.5.6 FRONT MONITOR NOT DISPLAYING ANYTHING

- Make sure the front monitor is on.
  - Make sure correct source/input is selected
- Open Internet explorer and move the Count Screen display to the front monitor.
  - Shift>Windows Key>Right Arrow
  - For more details reference PDF doc "Moving the Count Screen to the TV Display"
- If the PLC count is not changing, close the explorer page and reopen it again.
  - If can't clear, call Tech Support

### 12.5.7 TRAILER FILE NOT UPDATING

- Has the system been powered down overnight?
- Press Try New Trailer File button a few times
- After a timer done, if new trailer file didn't show, switch to Event Log tab then back to Operations.

### 12.5.8 FMH FLEXIBLE CONVEYOR NOT WORKING

- Check the main connectors between modules. Disconnect/reconnect.
- Inspect rubber O-rings for missing/damaged/or binding belts on the conveyor.
- Inspect sensors for power lights and clean if dirty.
- Inspect motor and pulley for loose or missing shaft key?

#### 12.5.9 RESETTING PC

- Best way to shut down the PC monitor
  - Windows icon>Shutdown
  - Power up by pressing blue button on side of monitor
- If PC frozen/lock up
  - Press blue button next to monitor until PC shuts down
  - Press blue button once more

# **12.6 System Troubleshooting**

- 1. If a box has stopped on a sorter module or sorter infeed (rollers) and the dome light is yellow:
- a. Look on the screen and identify the location of the stopped box.
- b. Remove the box and place in the appropriate location.
- c. The system will start automatically. (You don't have to push start).
- 2. If a box has stopped on a sorter module and the dome light is red:
- a. Check to see if E-stop button(s) are pressed.
- b. If so, reset E-stop button.
- c. Press Start.
- 3. If a box has stopped on a sorter module and the dome light is green: a. Wait and observe, a lane is most likely full and the boxes will move once a lane is cleared.

Resetting the Software

- 1. Select the Reset tab.
- 2. Click the Reset the System button. On the popup message, Are you sure?, click Yes.
- Pushing the Reset button will close and restart the system and should only be done after all other troubleshooting efforts have failed to solve the problem.
- Remove all boxes before restarting system and wait several minutes for restart procedure to complete.

#### Removing a Non-Functioning Sorter Module

If a sorter module does not return to operation, follow these steps to remove it from the configuration:

- 1. Press the E-Stop button.
- 2. Remove the Sorter Module (Refer to System Tear Down & Put Away procedures).
- 3. Reset the E-Stop button. This triggers the system to rescan and may take 60 seconds or more.
- 4. The system is ready to resume operation. Press Start button.
- 5. Go back through the Daily E-Stop Verification System:
- A. Press an E-Stop button. It will light up and stay lit until reset.
- B. Verify that all mechanical functionality stops through the entire system.
- C. Reset the E-Stop by turning the red pushbutton clockwise and pulling it out.
- D. Restart the system by clicking the Start button.
- E. Wait for system to check and initialize the sorters.
- F. Do this for all E-Stop buttons before beginning normal operation.

**Note:** If the non-functioning sorter module is the one closest to the reject lane, the E-Stop Terminator cable must be removed from that sorter module and then placed on the sorter module that will then be closest to the reject lane.
